15. New Business: Forum Scheduling

See briefing note prepared by Louis Poirier (Bobsleigh)

- Louis provided a brief overview of the issue winter athletes face in attending the Forum given the scheduling of Forum in the Fall.
- On behalf of the winter sport athlete reps, Louis is asking AthletesCAN to review the scheduling of Forum to enable the attendance and participation of winter athlete representatives by way of proposing that AthletesCAN move to rotating the Forum dates from spring to fall.
- Louis moves that beginning 2013, the AthletesCAN Forum move to a 4 year rotation of the Forum dates: Spring Forum in 2013 & 2014 followed by a Fall Forum in 2015 & 2016. This pattern would continue every four years. Striking from the original motion as outlined in the briefing note circulated at the meeting is the specification of (Last week of April) and (Mid September).
- Motion seconded by Ryan Blais (Freestyle Skiing)

Open to discussion:

- Hugh Macdonald (Archery) in principle is in favour of this motion however is concerned with regards to the to the bylaws sections 51 and 49 with respect to the fiscal year of AthletesCAN and requirement of having an AGM every fiscal year. If the AGM is bumped around from year to year, would need to ensure that the organization is able to meet it's obligations and would recommend that somebody with some expertise review by-laws and make sure they are compatible with this proposed change.
- Ryan Blais (Freestyle Skiing) Given this information was not considered when the original motion was presented (re: issue of overlapping fiscal years) it is his recommendation that a committee be formed to review the motion presented by Louie and make recommendations to the Board. It was also suggested that Louis be part of this committee to ensure the winter sport voice is represented.
- Ryan Blais (Freestyle Skiing) proposed a friendly amendment to the motion that a committee be created to look into exploring the possibility of rotating the Forum dates and provide recommendations to the Board of AthletesCAN.
- Friendly amendment seconded by Louis Poirier (Bobsleigh).
- Erik Petursson (Diving) suggests that the Board report back to the membership at the next AGM on the status of review and discussions from the committee and Board.
- Josh Riker Fox (Modern Pentathlon) commented that it would be important to ensure that summer sports aren't excluded in discussions as they make up more of the sports.
- Amended Motion: Be it moved that a multi sport committee be formed to find an equitable balance, recommend forum dates and report back with recommendations by AGM 2011.
